Dear Mr. Moriarty:

The purpose of this letter is to update information pertinent to the asbestos removal and disposal situation on the referenced property in Marco Island. First, in an attempt to accelerate the asbestos clean up, the Department hereby waives the 10 working day requirement before commencement of cleanup activities.

In addition, and toward trying to accelerate the clean up efforts, the Department wants to advise you of possible violations for which you may be responsible and seek your cooperation in resolving the matter. There may have been violations with regard to the asbestos handling, which the Department wants to discuss. They relate to the removal of the asbestos pipe from Collier Boulevard, the staging areas on the Glon property, the handling of the asbestos pipe after the staging of the Glon property and the disposal of the asbestos pipe.

You are requested to meet with the Department to discuss these matters. We have tentatively reserved a meeting time at 2295 Victoria Avenue, Suite 364W, Fort Myers on April 25, 2006 at 10:00 a.m. to address these matters. Please advise us if you or your representative will be available to meet with us on that date. Potential penalties, which may include a monetary settlement, will be discussed at the meeting. The Department is interested in reviewing any facts you may have that will assist in determining whether any violations have occurred. You may bring anyone with you to the meeting that you feel could help resolve this matter.
